A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO GENSAVE SOLAR POWER ENGINEERING SERVICES FOR THE SUPPLY AND DELIVERY OF GENERATOR SET TO BE USED AT TCCT

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2026-05-0693** with an Approved Budget for the Contract (ABC) of **Php 720,000.00**;

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;


