**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO GUBAT ST. ANTHONY COOPERATIVE FOR THE SUPPLY & DELIVERY OF PASTEURIZED CARABAO MILK FOR THE FEEDING SUPPLEMENTATION OF UNDERNOURISHED CHILDREN AND PREGNANT WOMEN**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco adopted Small Value Procurement pursuant to Section 34 of the Implementing Rules and Regulations of Republic Act No. 12009 as the mode of procurement for **Purchase Request No. 2026-05-0721**, with an Approved Budget for the Contract (ABC) of **Php 1,167,000.00**;

WHEREAS, the BAC issued Requests for Quotation (RFQs) to bona fide suppliers, specifying the required technical specifications, quantities, ABC, and the applicable terms and conditions of the procurement;

WHEREAS, after the deadline for submission of quotations, the BAC received three (3) price quotations from **Gubat St. Anthony Cooperative, General Trias Dairy Raisers Multi-Purpose Cooperative, and The Rosario Livestock and Agriculture Farming Cooperative**;

WHEREAS, upon opening, preliminary examination, and evaluation of the submitted quotations, the bids of **General Trias Dairy Raisers Multi-Purpose Cooperative and The Rosario Livestock and Agriculture Farming Cooperative** were declared non-compliant for failure to quote on all required items and/or submission of incomplete bid requirements, while the quotation submitted by **Gubat St. Anthony Cooperative** was found to be complete and compliant with evaluation result as follows:

- b.) To recommend to the Honorable City Mayor of Tabaco the approval of the award of contract to **Gubat St. Anthony Cooperative** in the total amount of **One Million One Hundred Sixty-Five Thousand One Hundred Ten Pesos (Php 1,165,110.00)**;
