**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JOAQUINS NON-SPECIALIZED WHOLESALE TRADING FOR THE SUPPLY & DELIVERY OF FEEDING INGREDIENT (WHITE RICE AND MONGO BEANS) FOR COMPLEMENTARY FOOD**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-05-0727** with an Approved Budget for the Contract (ABC) of **Php 935,000.00**;
