A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ROLOSA CONSTRUCTION AND SUPPLIES FOR THE JOB ORDER - LABOR & MATERIALS FOR THE LINE EXTENSION AND INSTALLATION OF 25KVA TRANSFORMER AT SHARED SERVICE FACILITY AT COBO, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2026-05-0734** with an Approved Budget for the Contract (ABC) of **Php 451,970.80**;

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
