A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO POWER PRIME CAR SERVICE CENTER FOR THE SUPPLY AND DELIVERY OF REPLACEMENT TIRES FOR LONKING PAYLOADER OF CENRO
