A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DYNAMIC PYROTECHNIC DISPLAY AND EVENTS MANAGEMENT SERVICES FOR THE SUPPLY & DELIVERY OF FIREWORKS FOR THE TABAK FESTIVAL 2026 (MAINLAND, UPLAND, & ISLAND

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-05-0793** with an Approved Budget for the Contract (ABC) of **Php 600,000.00**.


WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


