A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO WAWI PRO AUDIO, LIGHTS, VIDEO LEDWALL & EVENTS FOR THE RENTAL OF SOUND SYSTEM WITH LED, ARCH TENT AND LIGHTS FOR THE TABAK FESTIVAL 2026

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-05-0794** with an Approved Budget for the Contract (ABC) of **Php 500,000.00**.
