A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BMT MARKETING FOR THE SUPPLY AND DELIVERY OF EMERGENCY GO BAGS, CDRRMO, TABACO CITY WITH CONTRACT ID CB_GOODS_2026-05-0005

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Emergency Go Bags, CDRRMO, Tabaco City with Contract ID CB_GOODS_2026-05-0005*, with an Approved Budget for the Contract (ABC) amounting to *Four Million Eight Hundred Forty-Four Thousand Pesos and 00/100 (Php4,844,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on June 09, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

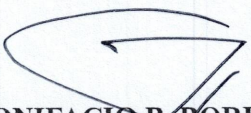
