A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO LIXSOURCE TRADING FOR THE SUPPLY AND DELIVERY OF INFANT WEIGHING SCALE, GAD-NUTRITION, TABACO CITY, UNDER CONTRACT ID NO. 007-09-2025-GOODS-PB-INFANT WEIGHING SCALE

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the **Supply and Delivery of Infant Weighing Scale, GAD-NUTRITION, Tabaco City, under Contract ID No. 007-09-2025-GOODS-PB-Infant Weighing Scale** with an Approved Budget for the Contract (ABC) amounting to **One Million Four Hundred Forty Thousand Pesos (Php1,440,000.00)** in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers have shown interest in participating by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on 15 October 2025, the BAC received two (2) bid proposals;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the bidder PLC Trading, Inc. failed to comply with the Technical Component and was subsequently disqualified;

WHEREAS, the BAC immediately conducted the detailed evaluation of bids of those which were rated Passed, and the result was as follows, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted the post-qualification of **LIXSOURCE TRADING**, the bidder with lowest calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that **LIXSOURCE TRADING** is

substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **LIXSOURCE TRADING** as the Lowest Calculated Responsive Bid (LCRB) for the **Supply and Delivery of Infant Weighing Scale, GAD-NUTRITION, Tabaco City, under Contract ID No. 007-09-2025-GOODS-PB-Infant Weighing Scale**; and
- b) To recommend to the City Mayor of Tabaco the award of contract to **LIXSOURCE TRADING** in the amount of **One Million Three Hundred Ninety-Six Thousand Eight Hundred Pesos and 00/100 (Php1,396,800.00)**.
