A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO LIXSOURCE TRADING FOR THE SUPPLY AND DELIVERY OF DRUGS AND MEDICINES (FOR CHU MEDICAL CONSULTATION), CHU, TABACO CITY with Contract ID CB_GOODS_2026-05-0007

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Drugs and Medicines (for CHU Medical Consultation), CHU, Tabaco City under Contract ID: CB_GOODS_2026-05-0007*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Three Hundred Four Thousand Seven Hundred Twenty-One Pesos and 00/100 (Php2,304,721.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on June 10, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

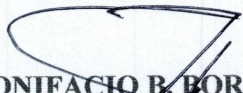

- b) To recommend to the City Mayor of Tabaco the award of contract to *LIXSOURCE TRADING* in the amount of *Two Million Two Hundred Forty-Three Thousand Six Hundred Three Pesos and 93/100 (Php 2,243,603.93)*.

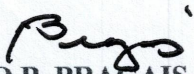
