A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JMB AUTOMOTIVE CARE SERVICES FOR THE JOB ORDER: LABOR & PARTS FOR THE REPAIR OF L-300 MOTOR VEHICLE (PLATE NO. SHE-610)
