NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a.) To award the contract to **Metromed Distributors Inc.** as the Supplier with Lowest Calculated and Responsive Bid (LCRB) for this procurement.
