A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES & GENERAL MERCHANDISE FOR THE SUPPLY AND DELIVERY OF MEDICAL LABORATORY SUPPLIES (FOR CHU MEDICAL LABORATORY SUPPLIES), CHU, TABACO CITY WITH CONTRACT ID NO. CB_GOODS_2026-05-0006

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Medical Laboratory Supplies (For CHU Medical Laboratory Supplies), CHU, Tabaco City with Contract ID No. CB_GOODS_2026-05-0006*, with an Approved Budget for the Contract (ABC) amounting to *One Million Seven Hundred Twenty-Nine Thousand Seven Hundred Ninety Pesos and 70/100 (Php1,729,790.70)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, three (3) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on June 15, 2026, the BAC received three (3) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

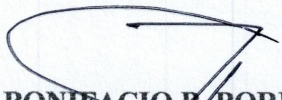

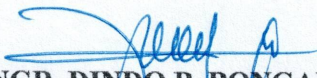

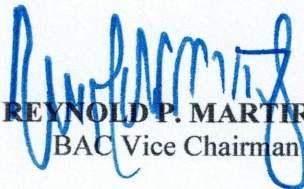

- b) To recommend to the City Mayor of Tabaco the award of contract to **MGM Medical Supplies & General Merchandise** in the amount of **One Million Six Hundred Thousand Forty Pesos and 17/100 (Php 1,600,040.17)**.

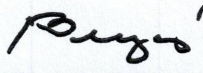
