A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE JOB ORDER-LABOR, MATERIALS, EQUIPMENT, RENTAL AND MATERIALS FOR THE REPAIR / IMPROVEMENT OF CITY HALL OFFICES AT TABACO CITY HALL ANNEX BUILDING AND OLD BUILDING, QUINALE-CABASAN, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-05-0695** with an Approved Budget for the Contract (ABC) of **Php 1,341,426.86**.

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
