A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JOB ORDER - SUPPLY OF LABOR, MATERIALS & EQUIPMENT FOR THE CONSTRUCTION OF BUILDING FOR TABAK MAKING / PRODUCTION (PHASE II) AT BRGY. COBO, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2026-05-0705** with an Approved Budget for the Contract (ABC) of **Php 1,600,000.00**;
