A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RRM ENTERTAINMENT PRODUCTION FOR THE COMMISSIONED WORK OF ARTIST (GUEST PERFORMER) DURING THE TABAK FESTIVAL 2026 ISLAND AND MAINLAND ACTIVITIES

WHEREAS, on June 01, 2026, the Office of the City Tourism, Culture and Arts (CTCAO) has submitted to the Bids and Awards Committee (BAC) Purchase Request No.2026-06-0835 requesting the procurement of Commissioned Work of Artist (Guest Performer) during the Tabak Festival 2026 Island and Mainland Activities with a total Approved Budget for the Contract (ABC) in the amount of **Php 240,000.00** sourced from the General Fund 2026;

WHEREAS, based on the result of the Market Study conducted by the End-User, **RRM Entertainment Production** has passed the criteria as Guest Performer during the Tabak Festival 2026 Highland Activities;

WHEREAS, the Bids and Award Committee has recommended to the City Mayor the use of Negotiated Procurement - Scientific, Scholarly or Artistic Work, Exclusive Technology and Media Services under Section 35.6 of the revised IRR of RA 12009 as the mode of procurement for the foregoing purchase request;

WHEREAS, upon approval of the said recommendation, the BAC has negotiated with **RRM Entertainment Production** the scope of service, the contract price and the terms and conditions of the contract;


WHEREAS, **RRM Entertainment Production** has offered to perform the service at a contract price amounting to **Php 240,000.00**;




