A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLIES FOR THE JOB ORDER: LABOR & MATERIALS FOR THE INSTALLATION / IMPROVEMENT OF UPLAND WATER SUPPLY SYSTEM AT HMR, SAN VICENTE, TABACO CITY
