A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CPQ COMPUTER CENTER FOR THE SUPPLY & DELIVERY OF DESKTOP COMPUTER SET FOR CITY ENGINEERING OFFICE
