**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO
DOMZ CONSTRUCTION SERVICES FOR THE JOB ORDER: LABOR, MATERIALS, AND
EQUIPMENT RENTAL FOR THE R & M BUILDING AND OTHER STRUCTURE, FATIMA,
TABACO CITY**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-06-0980** with an Approved Budget for the Contract (ABC) of **Php 1,599,654.38**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;

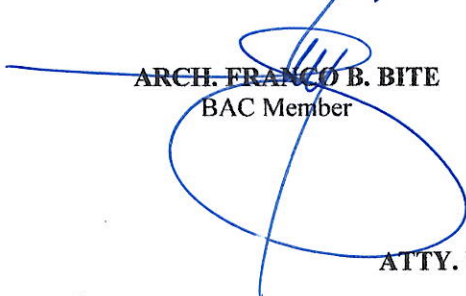
NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

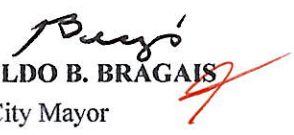
