A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MARVZ AUTOCARE SERVICES FOR THE JOB ORDER - LABOR & MATERIALS: REPAIR OF GARBAGE DUMPTRUCK HINO (JOE-197)
