**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO
SFM SALES CORPORATION FOR THE SUPPLY AND DELIVERY OF BRAND NEW MOTOR
VEHICLE FOR CHU - CITY NUTRITION**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-02-0205** with an Approved Budget for the Contract (ABC) of **Php 1,250,000.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, the BAC has sent the Request for Quotation for this procurement to bonafide suppliers, namely **SFM Sales Corporation, BMT Marketing, and Mabwheels Car and Truck Trading**, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, only **SFM Sales Corporation** and **BMT Marketing** have submitted its Price Quotation and the evaluation resulted as follows:
