A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BCVR PRIME ENTERPRISE FOR THE SUPPLY AND DELIVERY OF FEEDING SUPPLEMENTATION FOR SENIOR CITIZENS (FUEL FOR SENIORS & TB WARRIORS), GAD-NUTRITION, TABACO CITY UNDER CONTRACT ID CB_GOODS_2026-04-0002 (REBID)

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Feeding Supplementation for Senior Citizens (Fuel for Seniors & TB Warriors), GAD-Nutrition, Tabaco City under Contract ID CB_GOODS_2026-04-0002 (Rebid)*, with an Approved Budget for the Contract (ABC) amounting to *One Million One Hundred Thirty Thousand Five Hundred Eighty Pesos and 00/100 (Php1,130,580.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on June 29, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

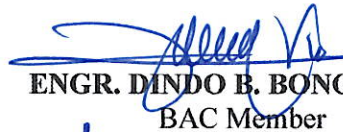
