A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BMT MARKETING FOR THE SUPPLY AND DELIVERY OF ONE (1) UNIT 6-WHEELER BRAND NEW GARBAGE DUMP TRUCK AND ONE (1) UNIT 4-WHEELER MINI DROPSIDE GARBAGE TRUCK, CENRO, TABACO CITY WITH CONTRACT ID NO. CB_GOODs_2026-06-0010

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of One (1) Unit 6-Wheeler Brand New Garbage Dump Truck and One (1) Unit 4-Wheeler Mini Dropside Garbage Truck, CENRO, Tabaco City with Contract ID No. CB_GOODS_2026-06-0010*, with an Approved Budget for the Contract (ABC) amounting to *Four Million Nine Hundred Thousand Pesos and 00/100 (Php 4,900,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on July 20, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

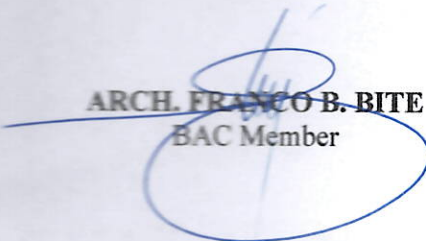

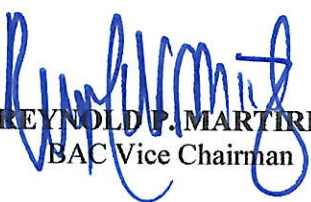

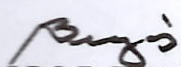
