A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO OPULENTO AGRIVENTURES FOR THE SUPPLY AND DELIVERY OF AGRICULTURAL SUPPLIES (FOR RICE, CORN, AND ORGANIC AGRICULTURE PROGRAMS), CITY AGRICULTURE OFFICE, TABACO CITY WITH CONTRACT ID CB_GOODS_2026-06-0008

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Agricultural Supplies (for Rice, Corn, and Organic Agriculture Programs), City Agriculture Office, Tabaco City with Contract ID CB_GOODS_2026-06-0008*, with an Approved Budget for the Contract (ABC) amounting to *One Million Five Hundred Thirty-Nine Thousand Three Hundred Pesos and 00/100 (Php1,539,300.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on July 16, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

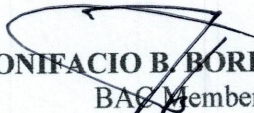

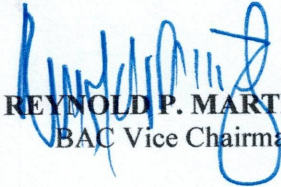

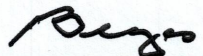
