A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ST. JOACHIM AND ANNE'S PHARMACY FOR THE SUPPLY AND DELIVERY OF DRUGS AND MEDICINES FOR MEGA HEALTH CARAVAN

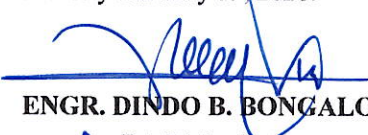
WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

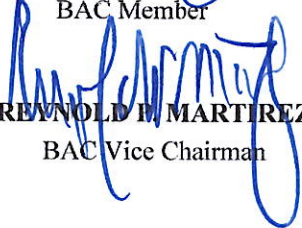

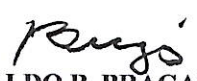
