A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO MEDICATUS PHARMA DISTRIBUTOR FOR THE SUPPLY AND DELIVERY OF MULTIVITAMINS FOR 6-59 MONTHS OLD CHILDREN, GAD-NUTRITION, TABACO CITY UNDER CONTRACT ID: CB_GOODS_2026-06-0009

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Multivitamins for 6-59 Months Old Children, GAD-Nutrition, Tabaco City under Contract ID: CB_GOODS_2026-06-0009*, with an Approved Budget for the Contract (ABC) amounting to *One Million Three Hundred Ninety-Seven Thousand Four Hundred Thirty Pesos and 00/100 (Php1,397,430.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on June 29, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

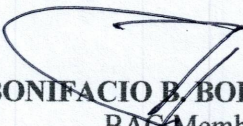
