**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO
LIXSOURCE TRADING FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES FOR MEDICAL
CONSULTATION**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-06-0897** with an Approved Budget for the Contract (ABC) of **Php 1,396,494.50**.
