**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SAN CARLOS
HARDWARE OPC FOR THE SUPPLY & DELIVERY OF SUBMERSIBLE WELL PUMP FOR DEEPWELL
