A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO
COTTON CITY MARKETING CORP. FOR THE SUPPLY & DELIVERY OF T-SHIRT WITH PRINT AS
ADVOCACY SHIRT FOR THE IDOL KO SI NANAY GRADUATES (NUTRITION MONTH CELEBRATION)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No.2026-06-1020** with an Approved Budget for the Contract (ABC) of **Php 212,500.00**.

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, **Supplyco Office and School Supplies Trading**, it was determined that its bid is non-compliant with the bid requirements, failing to indicate the brand of the offered items. Hence, its bid was disqualified.

WHEREAS, upon careful examination, validation and verification of all the document submitted by the supplier with the second lowest quoted price, **Cotton City Marketing Corp.**, its bid has been found to be compliant and responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To award the contract to **Cotton City Marketing Corp.** as the Supplier with Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b.) To recommend to the City Mayor of Tabaco the award of contract to **Cotton City Marketing Corp.** in the amount of **Two Hundred Five Thousand Four Hundred Eighty Pesos (Php 205,480.00)**.
