**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE & CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF CONSTRUCTION SUPPLIES FOR THE REPAIR AND MAINTENANCE WORK OF VARIOUS PUBLIC BUILDING (CITY HALL COMPLEX, CSWD, LEGISLATIVE BUILDING, SUPER HEALTH CENTER, ETC.)**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2026-07-1033** with an Approved Budget for the Contract (ABC) of **Php 928,360.00**;

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:
