A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SURE8COOL REFRIGERATION AND AIR CONDITIONING SYSTEM TRADING FOR THE SUPPLY & DELIVERY OF FLOOR MOUNTED AIR-CONDITIONING UNIT FOR SP/VMO SATELLITE OFFICE AND THE CITY LIBRARY & INFORMATION CENTER
