**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO
RAMPIXEL PRINTS AND DESIGNS FOR THE JO - LABOR & MATERIALS FOR THE PRINTING
OF VARIOUS CARDS AND PAYROLL FORMS FOR COLLECTION OF TAXES**

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-08-1209** with an Approved Budget for the Contract (ABC) of **Php 525,000.00**;
