CORRECTION OF INADVERTENT OMISSION OF THE PRE-BID CONFERENCE DETAILS IN THE INVITATION TO BID AND PHILIPPINE BIDDING DOCUMENTS

The Bids and Awards Committee (BAC) of the **City Government of Tabaco**, pursuant to Republic Act No. 12009, otherwise known as the **New Government Procurement Act**, and its Implementing Rules and Regulations (IRR), hereby issues this **Supplemental/Bid Bulletin No. 09-2026** to clarify and amend the Invitation to Bid (ITB) and Philippine Bidding Documents (PBD) previously posted through the Philippine Government Electronic Procurement System (PhilGEPS) on **19 August 2026**.

I. PURPOSE OF THIS SUPPLEMENTAL/BID BULLETIN

Upon review of the Invitation to Bid and Philippine Bidding Documents posted on 19 August 2026; the BAC noted an **inadvertent omission of the time of conduct of the Pre-Bid Conference**.

The omission is hereby formally corrected through this Supplemental/Bid Bulletin.

The BAC emphasizes that the correction is intended to provide prospective bidders with complete and uniform information concerning the procurement and to ensure transparency, equal access to procurement information, and orderly conduct of the procurement process.

II. PRE-BID CONFERENCE

The Pre-Bid Conference for the above-mentioned procurement shall be conducted as follows:

Time: 9:30 AM

Venue: BAC Conference Room, Mezzanine Floor, City Legal Office, 2nd Floor Annex Building, Tabaco City Hall, Tabaco City

The Pre-Bid Conference shall be open to prospective bidders. Attendance shall not be mandatory.

The Pre-Bid Conference shall discuss, clarify, and explain, among other matters, the eligibility requirements and the technical and financial components of the procurement project, including questions and clarifications raised by prospective bidders before and during the conference.

Prospective bidders are encouraged to submit requests for clarification in writing to the BAC at the address indicated in the Bidding Documents within the period prescribed under the IRR.

III. CORRECTION TO THE INVITATION TO BID AND PHILIPPINE BIDDING DOCUMENTS

Accordingly, the portion/s of the Invitation to Bid and Philippine Bidding Documents referring to the schedule of procurement activities shall be read and understood to include the following:

All other provisions, requirements, specifications, terms and conditions contained in the Invitation to Bid and Philippine Bidding Documents shall remain **unchanged and in full force and effect**, unless specifically amended by this Supplemental/Bid Bulletin or by a subsequent Bid Bulletin duly issued by the BAC.

IV. BASIS FOR THE ISSUANCE OF THIS SUPPLEMENTAL/BID BULLETIN

This Supplemental/Bid Bulletin is issued pursuant to **Section 51.4 and Section 51.5 of the IRR of Republic Act No. 12009**, particularly the provisions allowing the BAC to issue Bid Bulletins for purposes of clarifying or modifying provisions of the Bidding Documents and requiring any modification to the Bidding Documents to be identified as an amendment.

The BAC has determined that the omission of the Pre-Bid Conference details from the Invitation to Bid and Philippine Bidding Documents should be formally corrected and made available to all prospective bidders through a written Supplemental/Bid Bulletin.

V. EFFECT OF THIS SUPPLEMENTAL/BID BULLETIN

This Supplemental/Bid Bulletin shall form an integral part of the Bidding Documents and shall be considered by all prospective bidders in the preparation and submission of their bids.

All prospective bidders who have secured the Bidding Documents are advised to take note of this Supplemental/Bid Bulletin and incorporate the correction herein into their respective bids.

The Procuring Entity shall ensure the posting of this Supplemental/Bid Bulletin in **PhilGEPS**, in a conspicuous place within the premises of the Procuring Entity, and on the Procuring Entity's website or social media platform, if available, or through such other channels as may be authorized by the Government Procurement Policy Board, in accordance with the IRR.

Prospective bidders are likewise reminded of their responsibility to inquire about and secure any Bid Bulletins issued by the BAC in connection with this procurement.

VI. NO OTHER AMENDMENT

Except for the correction and clarification expressly provided in this Supplemental/Bid Bulletin, **there shall be no other change or amendment to the Invitation to Bid, Philippine Bidding Documents, specifications, eligibility requirements, terms and conditions, and procurement schedule.**

The deadline for the submission and receipt of bids shall remain:
