A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO CLIKZ COMPUTER & CCTV FOR THE LABOR AND MATERIALS FOR THE INSTALLATION OF AN EMERGENCY ALERT SYSTEM USING CCTV CAMERAS IN VARIOUS HAZARD-PRONE AREAS IN TABACO CITY, CDRRMO, TABACO CITY WITH CONTRACT ID CB_GOODS_2026-07-0011

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Labor and Materials for the Installation of an Emergency Alert System Using CCTV Cameras in Various Hazard-Prone Areas in Tabaco City, CDRRMO, Tabaco City with Contract ID CB_GOODS_2026-07-0011*, with an Approved Budget for the Contract (ABC) amounting to *Five Million Seven Hundred Eighty-Eight Thousand Four Hundred Forty Pesos and 00/100 (Php5,788,440.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on August 19, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

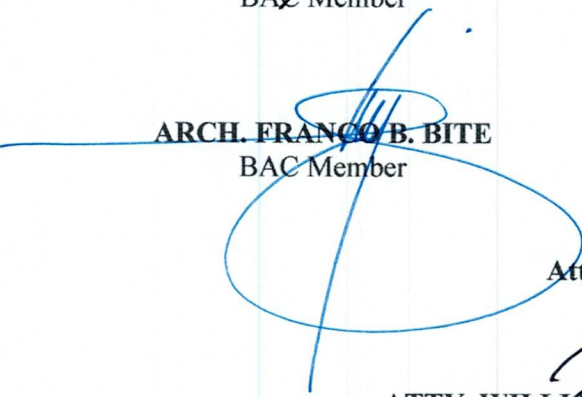

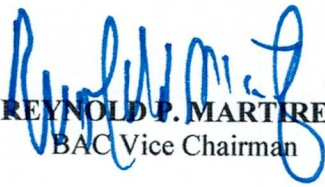

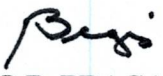
