A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M
HARDWARE & CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF ELECTRICAL SUPPLIES
FOR THE REPAIR & MAINTENANCE OF STREETLIGHTS ALONG TABACO/LIGAO ROAD, TABACO /
TIWI ROAD, BONIFACIO ST., AND VARIOUS PUBLIC BUILDING ELECTRICAL COMPONENTS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2026-07-1030** with an Approved Budget for the Contract (ABC) of **Php 896,950.00**;
