A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO AMARELAB MEDICAL SOLUTIONS MARKETING INC. FOR THE SUPPLY AND DELIVERY OF MEDICAL EQUIPMENT FOR THE CHO LABORATORY, SUPER HEALTH CENTER, AND LYING-IN FACILITY, CITY HEALTH OFFICE, LGU8-TABACO CITY WITH CONTRACT ID CB_GOODS_2026-08-0012

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Medical Equipment for the CHO Laboratory, Super Health Center, and Lying-In Facility, City Health Office, LGU-Tabaco City with Contract ID CB_GOODS_2026-08-0012*, with an Approved Budget for the Contract (ABC) amounting to *Two Million One Hundred Nine Thousand Four Hundred Ninety Pesos And 00/100 (Php 2,109,490.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on September 03, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

- b) To recommend to the City Mayor of Tabaco the award of contract to *Amarelab Medical Solutions Marketing Inc.* in the amount of *Two Million One Hundred Thousand Pesos and 00/100 (Php 2,100,000.00)*.

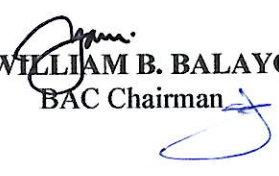
