A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO AIMS AGRI VENTURE, INC. FOR THE SUPPLY AND DELIVERY OF POST-HARVEST FARM EQUIPMENT (RICE COMBINE HARVESTER) FOR THE CITY AGRICULTURE OFFICE, LGU-TABACO CITY WITH CONTRACT ID CB_GOODS_2026-08-0013

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of Post-Harvest Farm Equipment (Rice Combine Harvester) for the City Agriculture Office, LGU-Tabaco City with Contract ID CB_GOODS_2026-08-0013*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Four Hundred Thousand Pesos and 00/100 (Php2,400,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission of bids on September 03, 2026, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:
