**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO

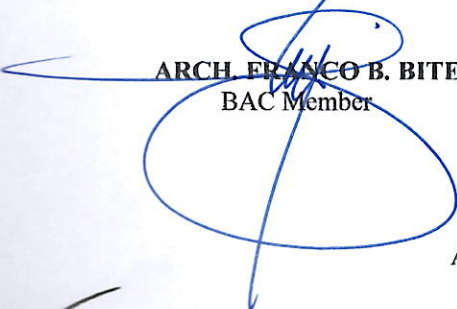
WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;

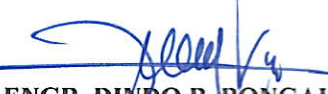
NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

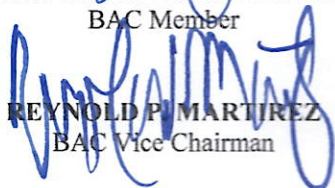
- To award the contract to **BONDSTONE Security Agency OPC** as the Supplier with Lowest Calculated and Responsive Bid (LCRB) for this procurement.

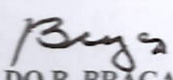
