**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO
189 BISTRO CATERING SERVICES FOR THE SUPPLY AND DELIVERY OF MEALS FOR TEACHER'S

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-08-1304** with an Approved Budget for the Contract (ABC) of **Php 625,000.00**;
