A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO - LABOR AND MATERIALS FOR THE REPAIR AND MAINTENANCE OF ANTENNA TOWER (VHF REPEATER SYSTEM) AT BUANG, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA 12009 as the mode of procurement for **Purchase Request No. 2026-08-1322** with an Approved Budget for the Contract (ABC) of **Php 400,000.00**;

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;

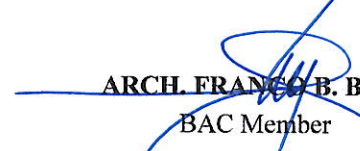
NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:
