Procurement of Service of Travel Agency for the 1st Knowledge Exchange Activity of the City Agricultural  
and Fishery Council (CAFC) and Sectoral Committees, City Fisheries and Aquatic Resources  
Management Council (CFATMC), City Mayor, Office of the City Agriculturist and Office of the City

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt
