A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO
O. R. ROCHA CONSTRUCTION & SUPPLY FOR THE JO-LABOR & MATERIALS FOR THE
REPAIR/REHABILITATION OF PERIMETER FENCE (153M) AT FATIMA, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 34** of the Implementing Rules and Regulations of RA No. 12009 as the mode of procurement for **Purchase Request No. 2026-08-1361** with an Approved Budget for the Contract (ABC) of **Php 400,000.00**.
