A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA
CONSTRUCTION & SUPPLY FOR THE JO - LABOR AND MATERIALS FOR THE FABRICATION OF
STEEL RACK AT GSO, LGU - TABACO CITY
