A RESOLUTION RECOMMENDING THE APPROVAL OF THE AWARD OF CONTRACT TO BITS & BYTES I.T. SOLUTION FOR THE SUPPLY & DELIVERY OF DESKTOP COMPUTER AND LAPTOP FOR TRD OFFICE AND CITY LIBRARY AND VMO SATELLITE

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco adopted *Small Value Procurement* pursuant to Section 34 of the Implementing Rules and Regulations of Republic Act No. 12009 as the mode of procurement for **Purchase Request No. 2026-08-1199/1200**, with an Approved Budget for the Contract (ABC) of **Php 700,000.00**;

WHEREAS, the BAC has posted in the PHILGEPS website the Request for Quotation for this procurement and sent to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of quotations, the BAC received **four (4)** price quotations from *Bits & Bytes I.T. Solution, Infoworx Inc., Banchoy Consumer Goods Trading, and Jouir General Merchandise*;

WHEREAS, upon opening, preliminary examination, and evaluation of the submitted quotations, the bid of *Banchoy Consumer Goods Trading* was **declared non-compliant** due to failure to quote on all required items, while the quotation submitted by *Bits & Bytes I.T. Solution, Infoworx Inc. and Jouir General Merchandise* were found to be **complete and compliant** with evaluation result as follows:

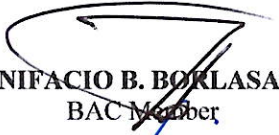

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;

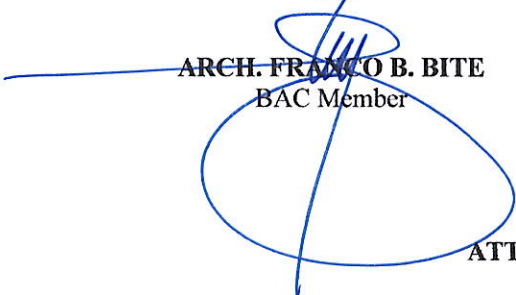
NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

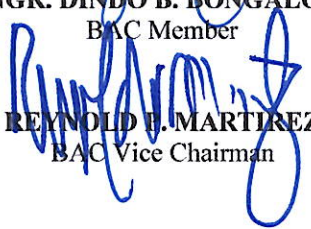
- To award the contract to **Bits & Bytes I.T. Solution** as the Supplier with Lowest Calculated and Responsive Bid (LCRB) for this procurement.
